## HAZWOPER FIRST RESPONDER AWARENESS LEVEL AND OPERATIONS LEVEL TRAINING

This course prepares employees, who are likely to discover or witness a release of hazardous waste, to initiate a response procedure by notifying the proper authorities, also known as **First responder awareness level**. **Operations level training** is for those individuals who respond to a release of hazardous substances by protecting nearby persons, property or the environment in a defensive manner.
